The meeting was called to order by Judge/Executive Joseph Pfeffer. Present were Commissioner Joseph McKay (District 1), Commissioner Annette Walters (District 2), Commissioner Phil Day (District 3), Deputy Judge/Executive Richard Newberry, County Attorney John Estill, Assistant County Attorney Jackie Sue Wright, Sheriff Patrick Boggs and County Treasurer Kim Muse.

Sheriff Boggs said to date, 92 percent of the 2015 tax bills have been paid. This collection rate is comparable to the previous year.

Sheriff Boggs presented the fee settlement for the Sheriff's Office for calendar year 2015. Receipts totaled, \$1,099,956.67 and disbursements totaled \$1,099,956.67, of which \$20,783.60 was excess fees paid to Fiscal Court.

Sheriff Boggs submitted the Monthly Vehicle Report for January for review and is attached hereto.

Sheriff Boggs discussed the future proposed upgrade of the radio system from analog to digital. Kenny Adamson with the Maysville Dispatch estimated quotes for the upgrade. The CRMS money, which is the cell phone tax money, is restricted as to how it is spent. This is used for in house software and equipment at the dispatch center, as well as for dispatchers' salaries. Therefore, most of the upgrade will have to be paid out the general funds of both the Mason County Fiscal Court and the City of Maysville. Buffalo Trace is already seeking grants for all agencies that would be affected by the upgrade. In the sheriff's office, the estimated cost for portable radios as wells as the radios in the department vehicles is \$95,000. The estimated cost of radios for the county road department is \$60,000.00. The infrastructure upgrade cost is estimated to be \$500,000.00

However, after viewing the damage, Larry Tichner with the Department of Highways believes the repair needed appears to go beyond the footage detailed in the bids. He estimated the repair to extend an additional 200 feet because he foresees a problem upstream if the repair is not extended the additional length. Judge/Executive Pfeffer is filing a request for emergency funding for the repair to the road. At this time, portable stop lights and a message board are in place to direct traffic.

B. Internet Service for Volunteer Fire Departments – E911

Lewisburg Fire Department operates the E911 internet service used to communicate with all the volunteer fire departments throughout the county via internet with cell phone numbers that are programmed into the system. This was implemented as a support system for firefighters to maintain contact when their portable radios lose reception. Chief David Kalb with the Lewisburg Fire Department asked fiscal court to reimburse the fire department the annual fee charged by Limestone Cablevision in the amount of \$539.40.

D. County Clerk Settlement

County Clerk Stephanie Schumacher presented the fee settlement for the Mason County Clerk's Office for the calendar year 2015. Receipts totaled \$4,170,515.34 and disbursements totaled \$4,055,991.79, leaving excess fees in the amount of \$114,523.55 payable to fiscal court.

County Attorney Estill spoke with members of the court about a lawsuit filed in 2007-2008 by the Maysville-Mason County Planning Commission and Mason County Fiscal Court against Steve Klump and Mason County Auto Sales in Mason Circuit Court. As a result of this lawsuit, a permanent injunction was entered. In a recent visit to Mason County Auto Sales by County Attorney Estill and Sheriff Boggs, the property was found to have several violations against ordinances enacted and therefore, is not in compliance with the injunction that was entered in the circuit court case in 2007-2008. County Attorney requested the fiscal court to give him permission to file pleadings in Mason Circuit Court to enforce the permanent injunction from the 2007-2008 lawsuit.
