Executive Order 21-02: Emergency to Replace Oak Woods Road Bridge

John Estill reported the County was mandated by the Kentucky Transportation Cabinet to close the culvert bridge carrying Oak Woods Road over Indian Run Creek. Upon the mandated closure, Judge Pfeffer issued Executive Order 21-02 and filed an emergency funding application with the Transportation Cabinet, which has been approved in the amount of \$72,560 (80% of total project cost of \$90,670. E & E Contractors began the replacement on the bridge on February 8. A motion was made by Commissioner O’Hearn and seconded by Commissioner McKay, to authorize Commissioner Phil Day to sign any Agreements relative to the project and authorize Treasurer Kim Muse to make payment to the Contractor for expenses for replacement of the bridge.

COVID-19 Vaccination Incentive Pay

County Attorney Estill reported the County Treasurer serves as the Human Resources Officer. He further reported that there was a low participation by eligible front-line employees to receive the COVID-19 vaccine. It is a benefit to the County all employees to be vaccinated and recommended to offer an incentive to staff who is vaccinated. Motion was made by Commissioner O'Hearn, seconded by Commissioner McKay, to approve that all full-time and part-time employees of the County who are not elected officials, are eligible to receive incentive pay of \$250 (before mandatory withholdings) upon showing proof of full vaccinations. For employees who have already been vaccinated they need to provide proof to the County Treasurer to receive their incentive pay.


