Mason County Fiscal Court Regular Session October 10, 2017 9:00 a.m.

Judge/Executive Joseph Pfeffer called the meeting to order. Present were Commissioner Joseph McKay (District 1), Commissioner Annette Walters (District 2), Commissioner Phil Day (District 3), County Attorney John Estill, Assistant County Attorney Jackie Sue Wright, Deputy Judge/Executive Richard Newberry, County Treasurer Kim Muse, Jailer Lisa Kern-Yeary, Todd Leonard, Joe Brown and Steve Frodge.

Judge/Executive Pfeffer introduced Allison Adams, Director of the Mason County Health Department, to members of the court. Adams spoke to members of the court about the syringe exchange program, which has been in existence for one year now. There are 24 participants and to date, 847 used syringes have been collected while 1,158 new syringes have been distributed to the participants. The cost of the program to date is \$16,327.00. Of the 24 participants, five have been referred to drug treatment and six have been referred for Hepatitis C care. Adams said she is considering implementing the syringe exchange program as a regular clinical service instead of set hours on Tuesdays. Adams thanked fiscal court for their support of the program.

Motion made by Commissioner Day, seconded by Commissioner Walters to enter into the Mason County Affiliation Agreement, with noted corrections to be made, between Buffalo Trace Area Health District Department and Mason County Emergency Management.

Road Department

In other business, Brown informed members of the court that the road department received only one of the two dump trucks that was previously approved for purchase at the August 15, 2017, regular meeting. The other truck had mechanical issues and therefore, the county would not be purchasing it.

Brown found another dump truck, a 2004 model, with 40,000 miles, for \$19,900. Judge/Executive Pfeffer explained to members of the court that there is money in the budget to purchase the truck.

Lastly, Brown said the road department has hired a mechanic, who will start work on November 6, 2017.

If not, Judge/Executive Pfeffer has the authority to proceed with the next lowest bid for project 5, which would revert to Rayburn Excavation LLC.
