2021 Sheriff's Budget

Sheriff Patrick Boggs presented the budget for the Mason County Sheriff's Department for 2021 with estimated receipts totaling \$1,298,547.44, disbursements totaling \$1,278,547.44 with excess fees totaling \$20,000.00.

Motion made by Commissioner O'Hearn, seconded Commissioner McKay approving the budget for the Mason County Sheriff's Department for 2021 as presented by Sheriff Patrick Boggs as presented and attached hereto.
