Ordinance 21-06 Findings of Fact regarding Steve Wagler & Planning/Zoning Commission

Judge/Executive McNeill welcomed Robin Rice to brief the court in regards to the findings of Planning/Zoning Commission with regards to Zoning Application Request by Steve Wagler owner of Pleasant View Furniture on US 68 in Mayslick, KY. They were permitted to open and operate as a furniture store without expansion to be 'grandfathered' in. The property in question is not zoned for a commercial business. The application to joint planning commission was to open a seed/feed store and the findings were not that this ever occurred. The seed/feed store would have been permitted because it is agricultural in nature.

Next to speak on this matter was George Larger from the joint planning commission which he gave a little history of the business and how this became an issue. Essentially, the business expanded and grew to an 8-acre commercial business. This is no longer considered as 'grandfathered' because it expanded without the zoning changes.
