Sheriff Boggs explained to the court that both the City of Maysville and the sheriff's department applied for a grant and were awarded funding for the encryption of the portable radios. With this encryption, people using scanners can longer hear what is being said on the portable radios. Sheriff Boggs further explained to the court that he can longer buy the portable radios his

deputies are currently using. Instead of loading the encryption chips into radios that cannot be replaced, he advised it would be best to buy new radios. He received a bid from Southern Communications for \$13,327.35 for the purchase of 15 new portable radios. These will match up to the current digital system and will accept the encryption chip. Sheriff Boggs also said if the purchase of the new radios were approved, he would like to give five of the current radios to Clay Buser, with emergency management for use as needed.
